MUSIC MINISTRY REPORT 2018

In searching for an adequate description for 2018, the best seems to be:

"WHEW!" It was a momentous year of celebrations, remembrances, and events!

To begin, the presented 22 anthems for the year, this averages 2 per month, as compared to 18 for last year. Membership was increased by two and an additional two for the special liturgical days, i.e., Easter and Christmas.

A special event – a Choral Christmas Concert – was revived and hosted by St. Andrew's United in Cochrane on Dec. 13th. Our choir and 3 other choirs participated to a packed house. The event was deemed a success and will be held again next year. The new host has not been officially announced.

Two events marked the year with unusual happenings: 1) the first Sunday of February (4th) saw our services cancelled due to a heavy snow with temperatures below -25 degrees Celsius; (2) the second event on Oct. 8, the church experienced a break-in that resulted in a shortened service and a cancellation of the choir's anthem. The scheduled guest speaker took it in good stride and delivered a well-prepared message.

In summation, I consider the health of the music ministry program at BUC to be fairly well-stocked, dedicated, and eager to continue as God would direct.

All together, donations were approximately \$270, which went towards projects and communities that the children researched and chose. Of course, the Fair was very interesting and showcased each region with tasty food as well. What a wonderful way to explore our beautiful country and learn where our Mission and Service donations go to help those in need, right here in Canada.

We resumed regular classes for Advent through Christmas and Epiphany with some various group activities, including a movie day on December 30th.

This year, the kids in grade 4 - 6 have been joining the youth group during their evening meetings held once a month. We meet from 6 - 7:30, then, the youth come to join in at 7:00pm. It has been a good opportunity to build friendships while exploring their faith journey.

There are many other events planned for the rest of the year, including after church hot dog lunch and Movie, more Clubhouse and Youth evenings, special Valentines activity and party. Also, Mothers Day fondue, Fathers Day Amazing Race, and of course, the Kids led Service on the last day of Sunday School on June 23rd. - Web based Making changes are accessible on all computers and mobile App to update.


New website features:

MINISTRY & PERSONNEL COMMITTEE REPORT 2018

I am happy to announce that with everything going on with the United Church of Canada the 2018 was a very calm and quiet year for the M&P Committee here at Balzac United.

While the United Church of Canada continues to work through their changes and restructuring, it is my duty as Chair of M&P to ensure that the Board of Directors stays informed with the smaller changes that are occurring. The end of the year saw our Presbytery change into a much larger region, I'm sure more changes will follow into 2019 as the details of how the new region – Chinook Winds Region are implemented. As the new organizations of regions evolve, I'm sure it will affect some of the management of the ministerial staff in all United Churches.

2018 also saw slight changes made to the salaries to all of our "Lay" personnel –Music Director, Secretary and Sunday School Teacher. This is the first increase that had been made in several years.

As mentioned in my report for 2017, I had mentioned Rev. Rita's request for a sabbatical in 2019. The early steps of requesting this sabbatical has been made to Presbytery/Chinook Winds Region as it was made during the transition. The request was also formally made to the Board and approved at the November 2018 meeting. As 2019 progresses arrangements will be made for Rita to be away on sabbatical from April 23, 2019 until September 4, 2019. This time includes: her remaining week of continuing education owed to her before July 1st, 3 months for sabbatical time and one month of holidays. Her area of study has yet to be determined. To help with the planning for Rita's leave, I welcome feedback from the congregation regarding what type of ministerial support/ spiritual guidance we all would like to have during this leave. Anyone who wished to join the M&P Committee and help with this planning, please let me know. My contact information is at the bottom of this report.

One of the changes that was approved during the last AGM in February 2018 was to increase the compensation that we pay our housekeeping staff. For 2017 & 2018 we currently pay \$300 per month, as an increase was approved in last year's budget and not issued. Starting January 2019 there will be an increase our cleaning budget to \$325 per month for the housekeepers.

The M&P Committee plays two roles. The first is handling the Human Resources needs of the Church which I outlined above. The second is dealing with any complaints or concerns that may arise from the congregation. Although any concerns that are brought to my attention are kept confidential, nothing has been brought to my attention during the past year.

If you have any issues or concerns that you would like to discuss, please contact me. All items brought to my attention are dealt with immediately amongst the parties concerned until they do not require further involvement for resolution. Please remember any disputes, concerns or conflicts presented to me and the M&P Committee stay confidential.

PROPERTY MINISTRY REPORT 2018

Balzac United Church as a facility is in great shape. Upgrades over the last couple of years have made the Property Minister's job easy with the exception of balancing a budget with fixed expenses. We have a growing congregation and we have struggled for several years running a deficit budget. The time has come for us as a congregation to recognize tough decisions are required to meet a balanced budget. If there is not an increased awareness from the congregation, services and expenses will need to be cut to get the 2019 budget in balance.

No major capital upgrades to the church are planned for this year and the property will be maintained in an "As Is" status.

Two events to note:

- 1. A stranger unknown to our church congregation was found inside the church when it was thought to have been locked and secured. Updated security protocols for persons who have keyed access to the church were generated by the Board.
- 2. The church was broken into by the back door being forced open. Items taken from the church were recovered and returned. We had several property angels that took care of repairs to the back door; those efforts do not go unnoticed.
- 3. Most of the property budget is fixed line items, meaning the budget line items are based on the rates we pay for any of the utilities year after year with some anticipation for increases based on facility usage. A significant increase in the garbage bin rates took effect Nov. of 2018. The septic system that the church has in place is a fixed volume tank storage for solid and liquid waste. Once again and fortunately for us our septic service company has honoured their rates for another year.

Planned upgrades for the church that Property will be investigating in 2019 will be put on hold pending Board approvals until the church reaches a realistic balanced budget.

It has been yet another great year at BUC with plenty of caring volunteer hands that make it all work. Thank you from the Property Chair to the Board for all the support and to you the congregation for making all things BUC as important to you as they are to the Board.

TREASURER'S REPORT 2018

For the year ending December 31, 2018 to the Annual General Meeting of the Balzac United Church on February 10, 2019

All revenue and expenses are recorded as they are received and paid except for insurance costs and presbytery dues. These two items are paid in the early part of the year but one-twelfth of the cost of each of them is recorded as an expense on a monthly basis. We do this so that the months that these are paid do not show an unusually large deficit. All capital expenditures are expensed in the current year, for 2018 there were no capital expenditures.

During 2018, we spent 94% of what we had budgeted for expenses and received 103% of our budgeted revenue giving us a surplus of \$810. Note that for 2018 the board approved a deficit budget of \$11,000. Therefore, our overall results were \$11,810 better than budgeted.

We had one Guaranteed Investment Certificate (GICs) come due during the year, which was not renewed due to cash flow concerns. We currently have \$97,091 invested in GICs at the Alberta Treasury Branch in Airdrie. The board's goal is to have our GIC's staggered such that one comes due every year and a decision can be made by the board as to its renewal depending upon cash flow, upcoming purchases and economic factors.

We exceeded our Mission and Service goal of \$8,600 by \$1,469 which speaks well of the congregation's continued concern for others.






