Our numbers have gone up in certain areas: page views, Instagram reach because this is the main source for getting information to users with no in person services the last 2 years.


Highlights:

EXTERNAL OUTREACH MINISTRY 2021

The work of the External Affairs Committee is to reach out to help those people outside of our congregation. It is work based on social justice and action. It includes both our local and the global community.

The work of the church is accomplished through working with others. Through these relationships the church is able to faithfully and more fully make a difference in the lives of vulnerable people.

In 2021 there were no in person events due to the Co-vid pandemic. Our outreach with the residents at Bethany was through the giving of handmade cards for Valentine's Day, Easter and Christmas. I made all the cards and the staff hand delivered them. Staff reported the cards are well appreciated and brighten a person's day.

Promoting Mission and Service was done by reading Minutes for Mission on 1- 2 Sundays a month on Zoom. In 2021 we raised more than our goal due to a most generous trust fund donation. Thank-you to all those who continue to donate to Mission and Service. You are living out God's mission!

Our ongoing Outreach to the Airdrie First Hamper Program, formerly the Lioness, was funded by donations of \$645.00 from the congregation which supported one hamper for a family of four.

Outreach to the Airdrie Foodbank was funded by donations which were down from last year related to not having Sunday service and no room in the budget for ongoing outreach.

Reconciliation with Indigenous People Project continued as an ongoing project. "The following excerpt was read at a Board meeting. "It is with sadness that we reflect upon the 215 children, who died as a result of genocide. They died because they were being forced to conform to a society that valued assimilation over diversity. The government and the church's focus was 'to civilize and Christianize.'

As we come to terms with the facts surrounding the discovery of the children at the Kamloops Indian Residential School, we reflect upon who knew, who kept the facts hidden, and who took those secrets to their grave to protect the perpetrators of this genocide.

Let us take a moment to express our grief at the continuing loss of Indigenous Women, Girls and Two Spirit people and to do what we can do as a community of faith to support the work of families seeking justice" (There are more you know, By Lee Spice, Pastoral

Relations Minister). In small compensation \$215.00 was given to the Chinook Winds

Regional Indigenous Ministry Fund. The congregation was invited to observe June 21 with services based on Aboriginal Day on Zoom in lieu of our regular service.

Typical Summary of Annual M&P Activities

Monthly – regular board meetings, check ins with people to ensure things are well

January – Update of ADP payroll account to process the mandatory increase on ministers' salary

February – Annual AGM Report

March – AGM meeting

April – review ministers' contract. For the past 6 years, Rev. Rita was considered a Retired Supply Minister which only allowed for an annual contract that needed to be renewed every July 1.

May – present minister's contract to the Board of Directors for approval. Once approved file paperwork for Region for approval.

July – file approved contract in personnel file. Check to make sure that all certifications and paperwork are up-to-date

2021 in Review

Balzac United experienced many highs and lows during 2021. With the pandemic continuing, our online services which had begun for Advent in 2020 were going well and providing many of us an outlet to connect with each other. For those of us who are not online, regular newsletter was created and mailed out regularly with much thanks to our church secretary Angela Wigglesworth.

This spring, the Board of Directors hired a new Musical Director. Alex Barbieri was first hired on a 3 month trial contract from May 1 to July 31. In July, after careful consideration, Alex was offered a one year contract from August 1, 2021, to July 31, 2022. Considering the church closure and online worship, Alex was offered a staged contract meaning that he is paid accordingly should the church be holding services online or in person.

As in past years the Board re-negotiated Rev. Rita's annual contract for renewal. After a restful August holiday, Rev. Rita notified the Board that although she will miss BUC, she would like to retire. A mandatory 90 day notice was given to dissolve her new contract agreement.

MINISTRY & PERSONNEL 2021 continued

In September, the Youth Leaders asked for permission to have outdoors activities with the BUC youth. The Youth Leaders worked hard all year maintaining a program and keeping the kids involved. The fall activities were well received, and a couple campfires were hosted at Nose Creek Park in Airdrie. The youth program continues to be strong.

Throughout the year the Board of Directors held many discussions regarding the health and safety of all members of our congregation regarding the different waves of the pandemic as it worked through our community. It was decided that come the beginning of Advent, the church would re-open for in person worship. A sound plan was put into place and for a few short weeks we were able to re-open the church.

The cleaners were re-hired. They did a thorough deep clean of the building after sitting empty for over a year. Afterwards they agreed to work month to month at the same rate as before.

Going forward into 2022 things to note:

- 1. Rev. Paul Mullen has been hired on a short term contract. He is working for BUC parttime, until the end of July
- 2. The hiring/search committee is actively working on looking for a new minister. Ideally we would like to have someone in place for September 1st start date.
- 3. With the increase of duties regarding ministerial changes, closure and communications, the M&P would like to increase the Secretary's hours from 4 hours weekly to 8 hours weekly to cover the extra work that is being done. The 2022 budget reflects this price increase.
- 4. The cleaners are on a month to month contract. As we closed at the end o December, it was arranged for them to do final cleaning in January. Their services have been placed on hold once again until we re-open.

PROPERTY MINISTRY 2021

The Balzac United Church Minister of Property role is responsible for the grounds, physical structures and all appurtenances of the church building. That includes plumbing, heating, water supply, access and parking and building proper.

During a regular year, we often get requests to use the parking lot for varied reasons such as overflow from the hall to staging areas for bicycle or running marathons. While these seem relatively minor in nature, they do expose the church to a higher risk of liability. Therefore, these requests need to be carefully detailed and documented with the applicant to ensure that they have included the Church parking lot on their own rider insurance policy, excluding the church from liability and finally that they leave it the way they found it. Of course, we have not seen any of those requests since the start of the pandemic.

Insurance for the building is the single largest line item that the Property Budget carries and is not one that we can control. Rising insurance rates for the province are directly affecting the church and there have been 2 recent claims for hail and wind damage that also have some long term affects to these rates. The church needs to be protected and this sort of damage to the building cannot go unattended without affecting future coverage.

The last year has been what could be described as uneventful from a property budget perspective. The church has not been open for services or the public up to the end of Nov of 2021, closing shortly afterward as the Omicron variant overtook the province. Prior to the secondary closure and in preparation for Rev. Rita's final pulpit message, the church Balzac Pew Crew met and moved all the pews out of the sanctuary and the carpets were cleaned and sanitized. The pews were restored to their original locations, modified to meet minimum distancing requirement and the protection of the congregation. Hand sanitizing stations were strategically placed at hot spot locations and a successful first in-church session since April of 2020 took place to appropriately allow the congregation to bid Rev Rita farewell.

The water storage system in the crawl space of the church had been plagued by a faulty connection to the pump that continued to fail and allow the tanks to slowly drain down. This has finally been rectified by physically supporting the connection between the flexible pipe of the tank system and the hard connection to the pump. It has been operating perfectly since this repair was facilitated. A great relationship has been established with Affordable Water Service Ltd. to establish reasonable re-fills with relatively short notice when required.

The remainder of the property budget is made of fixed expenses and the board has done a great job in fine-tuning and paring these down to the bare minimum to keep the building and grounds running smoothly.

As the church community embarks on some sort of re-opening, the church is in a fantastic condition to be re-opened when the Board deems that it is safe to do so.

TREASURER REPORT 2021

For the year ending December 31, 2021 to the Annual General Meeting of the Balzac United Church on April 3rd, 2022.

All revenue and expenses are recorded as they are received and paid except for insurance costs and the United Church's National Assessment. These two items are paid in the early part of the year but one-twelfth of the cost of each of them is recorded as an expense on a monthly basis. We do this so that the months that these are paid do not show an unusually large deficit. All capital expenditures are expensed in the current year, for 2021 there were no capital purchases.

During 2021, we spent 89% of what we had budgeted for expenses and received 85% of our budgeted revenue giving us a deficit of \$18,697. Note that for 2021 the congregation approved a deficit budget of \$8,500. Due to the continued effects of COVID-19 the federal government maintained the Canada Emergency Wage Subsidy which BUC qualified for. In 2021 we received \$20,374 from the federal CEWS program which improved our year end results to a surplus of \$1,678.

We had one Guaranteed Investment Certificate (GIC) come due during the year. The board decided not to renew it as cash flow for the upcoming year remained a concern. We currently have \$44,661 invested in GICs at the Alberta Treasury Branch in Airdrie. The board's goal was to have our GIC's staggered such that one comes due every year and a decision can be made by the board as to its renewal depending upon cash flow, upcoming purchases and economic factors. Currently we have 3 GICs, one maturing in 2022 and the remaining 2 maturing in 2023.

We exceeded out giving goals for Mission & Service and the Airdrie Food Bank in 2021 by \$3,053 and \$165 respectfully. Considering the effects of COVID-19 on in person services the congregation should be congratulated for thinking of others during these times.
