BUC celebrated Shrove Tuesday and Ash Wednesday on Feb 26, 2020. Joyce Covey and Sheryl Page graciously organized the event. Thank you.

BUC's last in person service was Mar 8, 2020.

BUC also participated in Groundhog Day, with Balzac Billy on Feb 2, 2020.

Once COVID 19 became a reality for Balzac United Church the Board made several difficult decisions. Therefore, Rev Rita provided a written service that was emailed out to the congregants each week. In June 2020 some of the more ambitious members along with Rev Rita met for coffee time via ZOOM. Rev Rita's computer was not up to date and in September/October a new system was purchased for Rev Rita to use. I, as chair of the worship committee, asked the minister in Peachland what and how they did they provided their Worship service work. Rev Rita also did much investigation as did Ruth Unser. Andrew Wigglesworth, Kevin Walkes and Clark Spencer were very helpful in selecting the equipment Rev Rita would need to provide Balzac congregation a worship service that most would be happy with. After many tutorials Rev Rita felt secure in agreeing to start the ZOOM Worship on November 29, 2020. It was great to see faces that we had been missing!!! I am so proud of Balzac United Church congregants for their support of the Worship Committee and Rev Rita through this difficult time. The worship committee and Rev Rita provided Balzac with a wonderful Christmas Eve Service that was shared with many people in many countries. CHILDREN AND YOUTH MINISTRY 2020

It has been a year full of challenges, surprises and blessings for the Sunday school team. We have now endured a full year of covid-19 and many restrictions which remove the possibility of in-person learning, so we have had to adapt our practices significantly. One of the many blessings during this time, is that when working with children and youth, we always have technical advisors to help lead the teachers through it!

In early September, while we were still able to hold socially distanced outdoor gatherings, we invited all Sunday school kids and their families to Pearce Estate Park in Calgary for an outdoor treasure hunt and check-in, as a kick-off to the Sunday school year. Three families attended, including six parents, two young adults, three kids, and one dog. We had a fun afternoon of treasure hunting, laughter, and reconnection. We also used this opportunity to give those in attendance their first Sunday school curriculum package.

The senior youth group has two group members regularly attending and two others in the age group who attend periodically. The junior youth have seven kids in the appropriate age group, however we currently have four kids who are attending our zoom sessions regularly. (one of the remaining three kids has opted to remain with the clubhouse group and is attending that group regularly, as per approval from the Sunday school teachers and parent.) The clubhouse group had four kids attend their first zoom session.

From September to November, the clubhouse group was sent resource packages through the mail with fun activities, crafts, recipes and more, as well as lessons for the parents to work on with the kids at home. The junior and senior youth classes held zoom sessions on Sunday mornings from 10-10:40 every second week. During Advent we increased Sunday school sessions to weekly, and as of January 22, the clubhouse group has added zoom sessions every second week as well. Zoe has also sent an offer out to all the clubhouse families to provide them with more take-home resource packages but has not received any requests at this time. The junior youth have made the request to continue with weekly Sunday school sessions rather than every second week. We have agreed we will work through Sunday school lessons every second week, and the kids will lead us in online games the alternating Sundays. All our groups have a lot of fun together and discuss our scripture readings with an emphasis on our current life situations.

In the fall Angela used the lectionary as a guide to create a Sunday school program focused on a journey through the wilderness. The junior youth talked and learned about Moses and the Israelites fleeing Egypt, and how their struggles with uncertainty, fatigue, impatience, anxiety and fear around the unknown, parallel our own thoughts and feelings during this pandemic. The theme throughout was trusting and relying on God to see us through our wilderness times. We then spent time during Advent in preparation for Christmas and the birth of Jesus, including Mary's journey to her cousin Elizabeth's home, Mary and Joseph's journey to Bethlehem, and the journey of the wisemen. In January we have started a journey along with Jesus as he begins his ministry. We will be spending time following his ministry right through Lent and Easter.

CHILDREN AND YOUTH MINISTRY 2020 continued

The senior youth have been focusing on studying the scriptures following the lectionary and have been engaging in lots of interesting discussions with Victoria, relating the scriptures to personal life experiences and global issues, and creating community from a distance.

The Sunday school team is currently planning for the remainder of the Sunday school year and are looking at several possible events including an all-ages Sunday school Valentine's day party, a virtual campfire during camping Sunday, a Pentecost event, and a virtual Mothers' day tea party; and will make decisions soon about ways to help kids connect through the spring, summer and fall.

YOUTH GROUP MINISTRY REPORT 2020

Spending time on zoom with the youth group has been one of the highlights of this covid-19 year for our team. We have been facilitating this group since December and decided this would be an excellent opportunity to help the youth develop their leadership skills in a controlled, safe environment. Each of the kids is assigned a week and it is their responsibility to plan youth group for that evening, including the activities and a closing prayer.

One week in advance of their evening, the youth member leading the session is asked to contact the leaders with their plan. We review the plan with the youth including details of the activity, required supplies, special considerations, and any prep required by the other youth group members (ie. What they need to bring to the zoom session). Once the session is completed, we send an email to the leader with feedback on the session.

The zoom groups have been a lot of fun, and the kids have been very creative in their leadership. So far, we have had a baking session with delicious mug cakes and food trivia quizzes, an evening of renaming ourselves and one another with positive affirmations, a treasure hunt, a Christmas party with a secret Santa gift exchange and more. All of the kids have had an opportunity to lead a session, and we are starting to have youth lead their second sessions over the next few months.

In February the youth group is going to be hosting a zoom valentine's day party for the entire Sunday school, and we are currently working on plans for the remainder of the year.

As of January 2020, we gathered over 147 followers on our Instagram page We have 83 followers on our Facebook page! Our Facebook public group has 30 members.

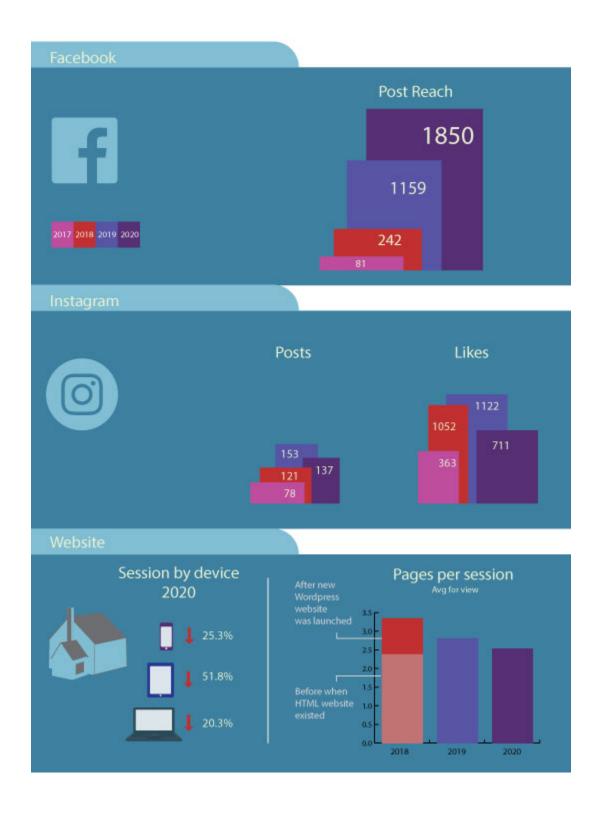

EXTERNAL OUTREACH MINISTRY 2020

The work of the church is accomplished through working with others. Through these relationships the church is able to faithfully and more fully make a difference in the lives of vulnerable people.

In 2020 the only in person activity we were able to complete was serving Afternoon Tea at the Bethany long-term care center. Congregation members Pat Koosey, Carolyn Collier, Liesel Pluemecke and I served tea with home baked treats every Friday In February.

Promoting Mission And Service was done by reading Minutes for Mission 2 Sundays a month by congregation members Kirsten Harrison, Susan Thomas and myself. This had to stop when services stopped due to Co-vid. In 2020 we raised \$7405.00 which was less than our goal of \$8600, but it was a remarkable amount considering we were not able to meet in person for 9 months of the year. The Sunday School was unable to celebrate with their Mission and Service Fair which I believe also contributed to the lower donation of funds. Thank-you to all those who continue to donate to Mission and Service. You are living out God's mission!

Our ongoing Outreach to the Lioness Christmas hampers was funded by \$500.00 with Board members jumping up to donate the extra that was not in the budget.

Outreach to the Airdrie Foodbank was funded by donations of \$1370.00. This is down from last year (\$1945.00) again related to not having Sunday service and no room in the budget for ongoing outreach.

Reconciliation with Indigenous People Project continued as an ongoing project.

The Board has committed to move forward toward reconciliation with our indigenous brothers and sisters. In 2016, 200 members of the Church gathered to acknowledge the 30th anniversary of apology to First Nations Peoples. When asked for suggestions on how the church can live out this apology, one of the residential school survivors, Alberta Billy, said

"I really believe that the church has to accept us: we are Indigenous to the land from the Creator, we had a way of life that was spiritual, we had thanksgiving for everything. The food from the ocean, the food from the forest. We lived with the land and we need to pursue those values again".

In this light the Board has read and studied the Declaration of Rights of Indigenous People and the Truth and Reconciliation calls to action as they pertain to the church. We have watched and discussed (via Zoom) 3 videos. Jim and I have gone back to University via Zoom and took a course called Indigenous Canada and we will prepare a report to the Board. Look for it in the future!

Jim and I also attended a Zoom 3-day intercultural event "New Wineskins" about honoring God's gift of diversity and how to move toward being an inclusive, intercultural church. One of the ways suggested was to observe June 21 with services based on Aboriginal Day. Let the Spirit Lead You. Allow the Spirit to work within you.

In December I handmade 75 Christmas cards and on your behalf gave them to the Bethany Care home residents. Staff reported that this made the residents happy and they all put them on their walls for decoration.

MINISTRY & PERSONNEL 2020

It is the role of the Ministry & Personnel Committee (M&P) to meet the needs of the congregants. We handle any issues that might arise whether they be a complaint about something that is happening in the church, to pass along accolades or even to connect someone to the appropriate person should they need assistance. Another role of the committee is to oversee the needs of the Human Resources duties required to ensure that the staff members of our church are happy and having their needs met. The M&P Committee IS NOT under the governance of the BUC Board of Directors but rather they are responsible to the Regional Council to whom they turn to for guidance. The Regional Council is also the governing body of the BUC Board of Directors. It is set up this way so that the M&P Committee remains impartial with regards to handling sensitive information. The Chair of the M&P Committee sits on the BUC Board of Directors and has the opportunity to provide the same input as other members on the Board including voting rights, however when it comes to items of dispute, accolades, connections, or human resources it is the role of the M&P Chair to present to the board the concerns in a confidential manner and advise in regard to solutions. All the information presented to the Board of Directors is kept private, no names or identifying information is shared, only an outline of a situation(s) that requires resolving at the Board level.

In the fall of 2019, it was brought to my attention that the Sunday School was running into an issue all small churches would like to have. Our classes were growing, and the age range was too great to break everyone into two suitable groups. It was felt that a third class was required to meet the needs of the younger students. As the M&P Committee we looked into the situation and presented the board with the request, offering a few solutions for them to work with. Over the course of a couple board meetings and intense discussions it was agreed that to encourage the future growth of the church a new position would be created. As this would involve a new budget line and expense to our operating budget this decision was not taken lightly and was thoroughly scrutinized by all of us as a whole. Unfortunately, when the budget was presented to the congregation during our 2020 AGM it was not approved ergo the program that we were developing for our youngest of congregants will not happen. Flash forward, due to COVID and its closures we have suspended this budget line for the 2021 year as we are unable to provide programming.

In March, our first board meeting via zoom happened. Part of the discussion was the renewal of Rev. Rita's contract and request for ongoing employment with BUC. This request/contract is negotiated between the M&P committee and Rev. Rita, when agreed upon the M&P Committee then presents the contract to the BUC Board of Directors for their approval. At this point the Board can either accept or request minimal alterations (some contractual items are a must provide as dictated from the United Church of Canada) to the contract. Once a mutually accepted contract is in place it is then forwarded to the Reginal Council for final approval. All ministerial contracts run from July 1st of one year to June 30th the following year. All other staff member of BUC are under the management of their BUC Board Chairperson Committee member, while their contracts are negotiated through the M&P Committee under the direction of the BUC Board of Directors.

MINISTRY & PERSONNEL 2020 continued

The United Church of Canada publishes annually a minimum salaries guideline that we must adhere to when it comes to ministerial compensation and benefits. The minimum salaries guideline is in effect from January to December each year and must be followed as outlined to us each year. Other staff salaries are determined by the Board as recommended from M&P.

Another M&P topic of discussion in our March zoom meeting was with regards to staffing and the closure of the building. It was decided to ask each staff member how they felt regarding the closure. Should they decide to stay on there was the expectancy of them providing the 20 hours a month in working hours (4 hours a week @ minimum wage) as per their employment agreement. It was at this time Lee Dowan had decided she would prefer a leave of absence as we were all struggling in how to share her talents with everyone during the closure. After some time and careful deliberation Lee reached out to me in the fall with her decision that perhaps our temporary closure would be a good time for her to retire as our Music Director. As Lee will be a difficult person to replace, the search has begun in finding a new Music Director for the church. Although we have this employment vacancy we would like to fill, there are a few unknowns related to the position due to COVID and re-opening protocols but we are accepting applications on-going from any interested parties.

Another discussion was with our Cleaners and our on-going contract with them. It was mutually decided that effective March 31, 2020 this contract would be dissolved. They did one last big clean before the end of March of 2020 and the interior of the building has not been cleaned since. Before reopening occurs, we will be required to have a cleaning company come in and have the building completely cleaned prior to services. We will also be in the need to either re-hire or acquire a new cleaning company for the church.

When setting our 2021 budget the following considerations were carefully made:

- There was a mandated annual increase to the ministerial salary.
- An increase to the Music Directors compensation in hopes to attract someone who would be a
 good fit for our church. Please note: this came after some heavy discussions and research into
 what would be reasonable in our budget. There were also great words of gratitude spoken
 regarding the legacy that Lee is leaving us with.
- The line item for a youth Sunday school leader was left empty as there is currently no programming anticipated for this year.
- We are required to carry a line item for a ministerial/pulpit supply person(minister) in case of emergencies. We left this line item empty due to our current closure.
- We carry a small budget for alternate musicians to play, in the case that our current musical director is unable. We left this line item empty due to our current closure.
- We have a line item to cover the cost of regional activities such as meeting and conferences. We left this line item empty due to the everyone's current closures and all meetings are currently online.

MINISTRY & PERSONNEL 2020 continued

I point out these items because when we do open, there will be a financial need to add these items back into our budget. Due to the current COVID-19 shutdown, there are some cost savings, but it is something that will eventually return and be required after re-opening when that happens.

After serving 10 years on the Board of Directors, I have decided that 2021 will be my final year. Thank you everyone who I have worked with to keep our little church a special place in all our hearts. If you might be interested in joining the board and taking over my position, please do not hesitate to contact me. I would be happy to discuss it with you.

PROPERTY MINISTRY 2020

2020 was a very peculiar year for all of us. A year that started fairly normally took on a very different dimension and by March we were in the midst of a worldwide pandemic.

We have a very solid and sound church building, considering that it is a hybrid structure of historic, old and a blending of new. Over the years we have added new carpet and a fresh coat of paint and finally at the end of 2019 we were fully independent with our own inhouse water supply. With approx. 1000 gallons of water stored in multiple tanks tucked into the crawl space, water pressure is provided by a pump that senses the demand and increases pressure when required. This particular pump style has been problematic and the connection right at the pump has been prone to leaking. It has been repaired a couple of times and finally the pump was replaced with a new one. Even with the lack of use through last year, it has begun leaking again and that will need to be addressed at the end of the first quarter of 2021.

Even though the church has sat quiet and idle, it was not able to escape the massive hailstorm that destroyed North East Calgary. What was thought to be a few hail stones through the siding turned out to be a significant amount of hail damage to the roof and the south and west facing walls. This will be the second year that we have had to make a claim for damage from severe weather. The latest replacement provided us with the best shingles made to be hail resistant. Nothing is hail proof and Asphalt shingles still provide the best protection from the elements. Others have inquired about steel roofing and the answer is it will fair no better than asphalt and in addition, carry a significant cash outlay for the steel. Not any decision that is in the best interest of the church itself.

The church has remained empty since April of last year and probably will be through the majority of 2021. The water supply will be emptied by an external pump prior to any in church activities to ensure that there is a fresh water supply when we need it. We have secured a relationship with a local supplier that sources water from the City of Calgary for a reasonable refill price with no additional fuel levies.

The property expenses over the last few years been leaned out to the max with the removal of Telus phone service, garbage bin rental/pick-up and finally the separation of water from the station next door which left us without water for several weeks near the end of 2019.

The budgets have been closely monitored over the last 5 years for trends and where savings can be achieved, prudent decisions were made by the board. Balzac United Church Property budget is a lean, clean budget with the largest expense being the Insurance for our building. This we cannot control and we will always be impacted by a major event similar to the massive storm of 2020.

I am proud of our minister for stepping up and leading us through service virtually. I am proud of the church board for never wavering in making the hard decisions and you, the congregation. Our church family! Without you this would not be any fun at all.

One never wants to overstay a welcome and the Minister of Property is no different. I will be happy to continue to serve if the congregation is supportive of that decision.

TREASURER REPORT 2019

For the year ending December 31, 2020 to the Annual General Meeting of the Balzac United Church on March 21, 2021.

All revenue and expenses are recorded as they are received and paid except for insurance costs and the United Church's National Assessment. These two items are paid in the early part of the year but one-twelfth of the cost of each of them is recorded as an expense on a monthly basis. We do this so that the months that these are paid do not show an unusually large deficit. All capital expenditures are expensed in the current year, for 2020 there were no capital purchases. We did replace our roof, however as this was an insurance claim, we were only responsible to pay the deductible.

During 2020, we spent 88% of what we had budgeted for expenses and received 96% of our budgeted revenue giving us a deficit of \$5442. Note that for 2020 the board presented a deficit budget of \$17,000 however this was not approved by the congregation. Due to the effects of COVID-19 the federal government enacted the Canada Emergency Wage Subsidy which BUC qualified for. In 2020 we received \$26,538 from the federal program which improved our year end results to a surplus of \$21,096.

We had one Guaranteed Investment Certificate (GICs) come due during the year, which was renewed for one year. We currently have \$77,961 invested in GICs at the Alberta Treasury Branch in Airdrie. The board's goal is to have our GIC's staggered such that one comes due every year and a decision can be made by the board as to its renewal depending upon cash flow, upcoming purchases and economic factors.

We missed our Mission and Service goal of \$8,600 by \$1,195. Considering the effects of COVID-19 on in person services the congregation should be congratulated for thinking of others during these times. All monies received for Mission & Service are paid to the United Church of Canada's M&S Fund.
