

HIRING COMMITTEE REPORT AGM 2022

The Hiring/Search Committee finished off 2021 with the retirement of Rev. Rita and started 2022 with the development of a job description for the ideal candidate that would best suit the needs for Balzac United Church.

In the fall of 2021, Dr. Rev. Stephen Harper had the committee work through a series of exercises to present to the Board. These exercises are designed to help us realize our identity in how the church has operated in the past and provides opportunity to take a deep introspective look on how our little church is changing. In hiring a new minister, change will happen no matter what and these exercises are designed to help the Board and the Hiring/Search Committee decide what kind of change would be to the best benefit of our little Community of Faith.

All these exercises (homework) were reviewed and discussed with us by Dr. Rev. Stephen Harper through each step of the process. In the end we were able to create a job description that needed to be submitted for approval to Chinook Winds Region before we could post the open position. The reasoning of this lengthy process was to make sure that we as a congregation were prepared for someone new to come in and lead our church and that the person we choose is the best fit for our needs. At the end of this process, we were offered two choices in the hiring process.

- 1. The first option being that we could select an interim minister and request a one year appointment. This involves regular check ins with Region and we could keep the position open for the next year until a final decision is made. We would also be able to continue to accept applications for the vacancy and conduct interviews. At the end of the year, we could choose to request that Region make the interim person we chose permanent and have them make the Appointment/Call official or we could go with someone else.
- 2. The second option is that we could forgo the Interim process and choose someone through the applications we received and make a request to Region to Appoint/ Call our candidate of choice. Once the Appointment/ Call is made and formalized from all parties involved (the church, being BUC, the minister & Region), it is considered final.

The Hiring/ Search Committee gave these choices some thought and felt that prolonging the hiring process throughout the next year would be unnecessary so the decision was made to go with the second option. We currently had Rev. Paul Mullen appointed to us from Region to be with us from January until June to provide us with guidance and support through the process so there was a sense of security in this decision.

Our job posting went live in mid-February. We received several applications from ministers located overseas who were looking to come to Canada. It was felt that BUC was not in a position to undertake someone from outside the country, so polite refusals were sent. We did receive a couple of local applicants and began the interviewing process after Easter.

In the end we had two people to choose from, both were strong candidates with each different pulpit styles. Thanks to COVID we were able to watch a few recorded sermons from each candidate. We conducted zoom and in person interviews held in the church. And then compared each candidate to who we felt would be best to help BUC move forward in the community and meet the best needs of our

congregation. This was a decision that was not taken lightly and our committee spent some time considering all our options. One of the driving forces in our decision was it was felt that BUC was in a period of change, and we needed someone new to help guide us through these changing times.

A congregational meeting was called for Sunday June 5th, were the Hiring/ Search Committee presented our chosen candidate. We answered many questions from all who attended. As a congregation a vote was made and in voting in favour of the presented candidate, we as a Community of Faith made a commitment to support and welcome our new minister.

Rev. Lynn McKinnon was officially Appointed/Called to Balzac United Church by Chinook Winds Region at the request of our congregation. Her official first day at BUC is August 1st, 2022.

With the official hiring and start of Rev. Lynn McKinnon to our little church, I thank all the hard work of our Hiring/Search Committee (Joyce Covey, Sheryl Page, Hazel Mountford, Clark Spencer, Ruth Unser) for your time, input and careful consideration as we worked through the process.

Now that Rev. Lynn has joined BUC, our committee is now dissolved.

PROPERTY MINISTRY 2022

The Balzac United Church Minister of Property role is responsible for the grounds, physical structures and all appurtenances of the church building. That includes plumbing, heating, water supply, access and parking and building proper.

The Board was successful in engaging Melcor Developments to discuss our continued and protected use of the north parking lot. After several positive phone conversations and information exchanges, Melcor suggested they would be amenable to a long-term usage Lease of the north parking lot to the Balzac United Church. A Lease document between Melcor Developments and the Balzac United Church for continued use of the north parking lot for 2 years; Feb 1st 2022 through and including Feb. 1 2024 was signed on April 24, 2022. This was a major achievement from a property perspective.

Natural spawling that occurs on concrete was becoming a maintenance and safety issue at the front entrance. A concrete company was commissioned to surface treat the steps in Oct of 2022 and it turned out really well.

Insurance for the building will continue to be the single largest line item that the Property Budget carries. Rising insurance rates for the province will continue to affect that budget line item into the future.

The challenges of a re-occurring leak problem with the fitting at the water pump in the basement has finally been rectified and we have a functional water storage system in the basement. The cistern type storage is currently in providing the church with stable supply of water.

The remainder of the property budget is comprised of fixed expenses weened down to the bare minimum to keep the building and grounds running smoothly.

As the church embarks and focusses on future growth; the church ready to accommodate the demands of more attendance.

TREASURER REPORT 2022

For the year ending December 31, 2022 to the Annual General Meeting of the Balzac United Church on March 19th, 2023.

All revenue and expenses are recorded as they are received and paid except for insurance costs and the United Church's National Assessment. These two items are paid in the early part of the year but one-twelfth of the cost of each of them is recorded as an expense on a monthly basis. We do this so that the months that these are paid do not show an unusually large deficit. All capital expenditures are expensed in the current year, for 2022 there were no capital purchases.

During 2022, we spent 98% of what we had budgeted for expenses and received 100% of our budgeted revenue giving us a deficit of \$6107. Note that for 2022 the board presented a deficit budget of \$8,500.

We had one Guaranteed Investment Certificate (GICs) come due during the year, was renewed for one year. We currently have \$59,159 invested in GICs at the Alberta Treasury Branch in Airdrie. The board's goal is to have our GIC's staggered such that one comes due every year and a decision can be made by the board as to its renewal depending upon cash flow, upcoming purchases and economic factors.

The congregation continued to remember others during 2022 by giving to M&S, the Airdrie Food Bank and Soap for Hope. All monies received for Mission & Service are paid to the United Church of Canada's M&S Fund.

This has been a transition year as I step away from the role of Treasurer and Hannah Walkes assumes the role. I would like to thank everyone for the support over the years, it has been truly appreciated. To Hannah, I trust the congregation will provide her all the support she requires and I will continue to be around when needed.






